EDUCATION

Educational Resources

Rationale

Education is a key ingredient in finding and retaining work and in being self-reliant. Elder Russell M. Nelson said, "In the Church, obtaining an education and getting knowledge are a religious responsibility. We educate our minds so that one day we can render service of worth to somebody else" ("Focus on Values," Liahona, Feb. 2013, 54; New Era, Feb. 2013, 4; Ids.org/liahona/2013/02/ focus-on-values). With appropriate education, individuals are more likely to find meaningful work and be better able to sufficiently provide for their personal and family needs. It also provides more opportunities for service both within and outside of the Church. Taking advantage of available educational resources can help an individual be successful in his or her career and life.

Objective

Increase Deseret Industries associates' awareness of educational resources and opportunities. Then help them use these resources to decide what type of education they would like to pursue as they plan their career and life.

Potential Discussion Items

- In weekly conversations with the Deseret Industries associate, make him or her aware of educational opportunities and funding through the Deseret Industries program.
- Follow up with the Deseret Industries associate on schooling plans, homework, due dates, and so on.
- Discuss available educational programs with the Deseret Industries development counselor.
- With the Deseret Industries associate, meet with the development counselor about educational resources available in the area or online.
- Provide the Deseret Industries associate with resources to research education possibilities.
- Help the Deseret Industries associate understand the importance of education by giving examples of the benefits of education or referring him or her to information that would motivate him or her to want to enroll in a program.
- Provide the Deseret Industries associate with information about career assessments and other testing that he or she can do with the Deseret Industries development counselor.
- Challenge the Deseret Industries associate to talk to people in the educational program he or she is interested in, conduct an informational interview, or talk to a school about the programs they offer.

county or a student at the college or university. There is usually a simple
application process to get a library card. Sometimes there is a small, reason-





able fee for some library services and resources.
